Signs, Signs, Everywhere There's Signs...

As some of you may have noticed, the board agreed to a proposal by Skip Clemmons to have new 3D cedar signs made for the main entrance in Columbia County. Donations were collected and more than half of the cost defrayed by the following: Skip Clemmons, Charlie Arnett, Phyl Rae, Joel Buzbee, Bob King, Carl Johnson, C. Johnson, R.O. Johnson, Jim Johnson, Darwin Perry, Knights of Columbus, Jule McGee, Michael Foret, Glenn Hunter, Mr. Conley, and Don Spradley. We are currently looking at getting signs for Suwannee County, and I'll be working with John Bryant on the number and locations.



In addition, the board has worked with Hunter Printing to generate 4' x 8' signs personalized for each park that show where you are, the 911 address, and a map of all the parks in relation to your current location. These have been built and erected by Jule McGee along with help from Charlie Arnett, Don Spradley, Wayne Sellers, Paul Morris, and Walt Sherrod. Hunter Printing is currently working on the Suwannee County images and gathering the 911 information for the signs in that county.



Improvements: Walt Sherrod has completed many projects, including an upgraded septic system, new roofs on the pavilions, and fixing the bathrooms at Hodor Park, countless repairs to gates, locks, fences, etc. at the other parks. He is currently working on a new gate for Bridge Park, reworking the gate at Point Park, fixing up Camping Park, repairing the deck at Mid-Point Park, and bringing in fill-dirt for Boat Ramp – Suwannee.

BY-LAWS – ARTICLE NINE – MEMBERSHIP PROVISIONS

All members in good standing, their relatives and their guests who accompany them shall have full use of the recreation areas owned by Three Rivers Estates Property Owners, Inc. This use shall include, but not be limited to, swimming, boating, picnicking and other recreation. Said recreation areas will be owned, operated, controlled and managed by the corporation. It is the intent of this corporation that utilization of said recreation areas be limited exclusively to lot owners in Three Rivers Estates, their relatives and their guests who accompany them. Use of the recreation areas by groups shall be in limited scope and number. Where the group using or planning to use a recreation area or areas exceeds or is expected to exceed twelve (12) persons in number, then permission for such use shall be first obtained from the president or vice-president or person designated by the president to act upon such request and in no event shall such approval be unreasonably withheld. No other persons or groups of non-members shall be permitted to use the recreation areas without prior approval of the Board of Directors with such approval duly noted in the minutes of the Board meeting. The officers of the corporation and their designees are directed to take such action as they may deem appropriate to prosecute trespassers and prevent unauthorized use of any of the recreation areas under the control of the corporation.

Recurring Theme

Recently, the lock on the main gate at Hodor Park had a key broken off in the lock, as well as a section of the fence destroyed. The key belonged to a vacation rental, and the folks were renting the house for the weekend.

Even more recently, a renter showed up at Hodor Park demanding that the gate greeters let the person in, using profanity and some very disrespectful words. This was followed immediately by the renter going back to the house, and inviting complete strangers to use the property to tube the river that may or may not live in this neighborhood.

These are just the most recent examples of the destruction of property and lack of respect for our parks that some of the vacation renters who do not live here have done in the past couple months alone.

As a result, the board is discussing measures aimed at the property owners who make money off of TREPO parks by renting their homes for vacation purposes. These discussions include charging higher dues to these business owners or requiring that the property owner escort the visitors to the parks, which by the way is already part of the bylaws.

It's obvious that these renters do not respect the parks that we work hard to maintain, since they do not live here. We have all worked too hard to clean these parks up and make them family oriented again to have this continue.
