\*President passed the application for *Gate Greeter Volunteer Form at Hodor Park* for comments/approval by board. We took one paid position out when some members complained on fee increase, and alot of folks at that meeting mentioned they wanted to volunteer. *Hours:* **9-6 Saturday;10-5 Sunday 10-5 Memorial Day (and other holidays).** If we don't get volunteers from the general membership, we will have to find a way to bring back a paid position. Persons are on standby. Concensus reached to use the application. \*Need power at the pavilions, since people are bringing crock pots, etc. and blowing the circuit. (2) 20 AMP servic should each run 5.

\*park Manager stated electrical upgrades also need to be made at Brennan Park...we need an extra circuit and a permit to fix 1 1/4" pipe that was hit by lightning. Suwannee County didn't want to approve permit. We have a quote from Burns Electric who put the service in initially. Chairman requests we also speak to Clay Electric. We need to have certified electrician(s) install circuits for future growth.

\*President notes that seven complaints have been voiced and Chairman says he would like to get those before the meeting, an he said they will review those complaints.

### 11. Park Managers Report, Bill Brim: please refer to separate report by Park Manager.

\*All parks are open. He's requested all members pick up branches when possible.

\*No vehicles are allowed in Brennan or Fishing Parks

\*Dogs are still being brought into parks, usually by the same people. Chairman noted we are working with legal group who are having conversations with County.

\*Pit Bulls and other dogs running off leash in our streets. County has Code Enforcement, they've hired a few people, however their procedure may not be enough.

\*Secretary showed photos of her cat being chased up trees; complaints have been filed, fines have been handed to dog's owners.

\*Chairman suggested we ask Animal Control to come talk to us about their procedure, etc. \*J.Baker suggests we post emergency numbers on our web page. J. Brim and President will work on that directory.

\*Some members feel rules don't apply to them. Glass, trailers, dogs; we're getting them on camera. \*Chairman also noted that it's the Park Manager's scope of work to keep track of violations. If they consistently violate,Chairman prefers law enforcement getting involved. \*Camping Park reservations must be made so we know when and who is camping.

\*It was determined that all pavilions and camp sites be reserved for specific durations, and after 30 minutes of no show, they be released.

**12. Maintenance Committee Report, B.Brim:** Reported on several repairs. Chairman asked about Port-o-Let's, since we had to remove some due to budget constraints.
