7. Vonda summarized October minutes for Chairman who was absent in October. Motion to Approve October Minutes: Wayne/Charlee, motion passes.

8. Secretary's Report: Hilda's out of town; nothing to report

9. Treasurer's Report, Vicki Sellers:

*She hasn't moved anything from membership into checking yet, it will be done this month, leaving approximately \$1,200 (min.) in account.

*A \$599 deficit for picnic/fish fry is fairly common, since our goal is not to make money on this event. Some of the unusual expense amounts:

\$3,029.00 legal fees

\$9,675.00 for 2025 keys.

\$8,718. Both sides, park repair and clean up. (\$3,512. to Holly Electric for work at Hodor (Columbia County), and Brennan (Suwanee County). And \$5,206.00 for park clean up (both counties). *Motion to approve Treasurer's report: Gloria/Mike motion passes.

10. President's Report, Terri Hester: Introduced food donation box (to be funded by Busy Bees as a service project) was discussed in detail by Vicki and then by the entire board. Vicki noted that the idea was initiated by her prayer group and brought to Busy Bees. It was agreed to have one box inside fenced Hodor Park, and another at Suwanee Boat Ramp. Vonda noted that someone on the Suwanee side would need to monitor their box, since park is not fenced. Also, proper signage for what it is, what it's for, etc may be needed. The project was approved.

11. Park Managers Report, Bill Brim:

Please refer to Park Manager's separate report. Thanks were given for:

*Great group of people did a fine job clearing Suwanee side up including welding the gate.

*And all the members that have helped clean up parks in general.

*Suwanee County Parks is responsible for keeping the new trail along 27 safe; they have funding for maintenance. They plan to close off the path for vehicles.

*People are tearing the slopes up. FDOT did the highway portion.

*DUKE Energy still has not gotten back to the Chairman regarding the ROW issues.

Bonnie will be a board member, so she won't be able to participate in the count.

*We need to purchase a **fast/efficient scanner and a small lap top computer** to view and send documents to scanner. Vonda will shop Black Friday sales.

14. New Business: Chairman appoint committee chairpersons who wil bring up names of those in their committees the first of the year:

*Tommy Mathews: take on the with Maintenance including Suwanee County and Columbia County Boat Ramps (which Chairman has been speaking to both counties). Clubhouse renovation, and A frame to become an office.

*Vicki Sellers to head up the Finance committee.

*Bonnie Blackwell, to head up Code Enforcement and County rules related to VRBO's and rentals and come up with proposed solutions to resolve things we've been talking about.

16. Open meeting Property Owner's:

*Sheri Smith accused board of not providing enough detail on what was required for Park clean up where her business bid \$20,000. Jarrod Buttram also complained and mentioned his friend had bid around \$12,000.

<u>NOTE</u>: after receiving high bids, Chairman chose to get the work done for about 1/4 by renting equipment for one week (\$2,565.00) and hiring 2 people to do the labor (\$2,641.00), for a total of \$5,206.00. Those 2 people will file W-9 forms and be provided 1099 by TREPO.

*Jerrod Buttram was upset about electricity being out on Suwanee Park side and threatened Chairman, who noted J. Buttram did not have correct facts and Chairman requested this discussion be shut down or he would call law enforcement if this misinformation continues. *Vice Chairman motioned to adjourn the meeting; Vonda seconded.
